## Initial Application for the BS Foods and Nutrition Degree – Concentration in Nutrition and Dietetics /MS in Nutrition Combined Degree Program

## Instructions:

Step 1: Application to the Combined BS/MS degree must be submitted no later than **September 15 of the fall starting date of your senior year**. Applicants are to submit the completed form to the Department of Foods and Nutrition to begin the initial review and approval.

Step 2: If your application is approved, applicants must complete the CSE Graduate application process through the Admission Office.

Interested students should refer to the College Catalog and the FN Undergraduate Handbook for further information of the combined BS/MS degree program. The BS/MS program is designed for the full-time undergraduate students. Students must plan the completion of their undergraduate coursework carefully. Students should plan to complete all CSE essentials (Gen Ed) requirements prior to their senior year.

DPD Verification statements will be issued upon completion of the BS Degree, and students will be eligible to sit the Nutritionist/Dietetic Technician Registered (N/DTR) examination should they wish to do so. Students who complete the BS/MS degree program are eligible to apply to a free-standing, ACEND-accredited dietetic internship to become a Registered Dietitian Nutritionist (RDN) upon completion of the graduate degree.

Based on your GPA eligibility, students may apply to both the BS/MS and for the pre-select option of the Combined MS/DI at the same time. However, based on the outcome of the acceptance, you may only select one program option to follow.

Please note that these two program options have different applications, and completion of this form is strictly for the Combined BS/MS degree. Application guidelines for the Combined MS/DI are available through the DI Office.

**Note:** Students applying must first be accepted to Combined BS/MS <u>before</u> completing FN 500 Community Nutrition, FN 501 Medical Nutrition Therapy I and FN 503 Medical Nutrition Therapy II in order to receive the full nine (9) credits.

## Applicants will be notified of their acceptance on October 1

It is the applicant's responsibility to notify their course instructor for FN500, FN501 and FN503 regarding their intent to complete the BS/MS degree. Please read individual course syllabi for course requirements.
