## Founders Hall Roof Replacement

#### 1) Introduction

Saint Elizabeth University is issuing this Request for Proposal (RFP) to solicit interest from qualified roof replacement providers to replace the old flat and leaking roof on Founders Hall, a student residence hall at the University's campus in Florham Park, Morris County, New Jersey.

This RFP does not commit the University to award a contract or to pay any costs incurred in the preparation of a proposal. The University further reserves the right to reject all proposals received as a result of this request.

#### 2) Work Timeframe

Roof replacement work will begin immediately after the University's May 17, 2024 graduation Commencement and be completed as soon as possible, on a date to be negotiated with the Facilities staff in advance.

#### 3) Work Scope

- Stage dumpsters and other materials in a safe location agreed to by SEU
- Remove the existing roof in sections to prevent rain from entering the building
- Roof will be EPDM, white in color to reflect sun away from the roof
- All debris to be cleaned daily
- Interface with Facilities management daily
- Warranty to be included in bid package

#### 4) Site Information

Saint Elizabeth University is a private co-educational liberal arts University of the Catholic tradition representing students of diverse ages, backgrounds, and cultures. The University has two residence halls (O'Connor and Founders) housing undergraduate students with a combined total of 407 beds.

#### 5) Campus Vehicular Access

All construction vehicles must enter and exit from the main entrance connecting to Route 124 Madison Avenue and register with the guardhouse. Cameras are used by Security recording all vehicles entering/exiting from the campus.

#### 6) Tax Exempt Status

The University is a tax exempt institution of higher education, bids are not to include sales/use tax. A copy of the University's tax exempt form (ST-5) will be provided to the chosen contractor.

#### 7) Bid Proposals

Contractors will supply a written proposal by email attachment to the Facilities Supervisor Billy Andrinopoulos (Point of Contact). The proposal shall include the contractor's name, contact information including mailing address, phone number and email address. Roof Warranty and liability insurance coverage is to be included'

- Warranty of new roof
